- 10:10 A.M.** **2. ENHANCED NATIONAL HYDROGRAPHY DATASET (NHD) FOR POTENTIAL LOCAL APPLICATION**
Roger Barlow, United States Geological Survey (USGS)
The project encompasses 6 12-digit Hydrographic Units (HU) covering the District of Columbia. The Maryland Dept. of the Environment is also working on improving the stream network using lidar and orthoimagery source data in the Upper Rock Creek HU-12, and will be enhancing the upper Anacostia HU-12s in the near future. The enhanced National Hydrography Dataset (NHD) is a greatly improved stream network which includes a thinned network of DC Water storm-water pipes integrated with infalls/outfalls, culverts as connectors, and gaging stations as NHD "events". Surface-water streams are added using lidar source data and flow-accumulation routines. This will improve the existing NHD data for the District of Columbia from 1:24,000-scale to a scale more commensurate at the "local" level. In addition, the DOEE funded project is creating a 14-digit watershed delineation for the project using lidar 1-meter digital elevation models, and also 16-digit HU "catchments" in DC only.

monitoring network and future monitoring guidance at those stations to establish/continue trend load analyses for the major Anacostia non-tidal monitoring stations.

 EPA, MDE, DOEE, and Tetrattech will provide an update on their collaborative effort to develop revised TMDLs in the Anacostia Watershed for a suite of Toxics including metals, organochlorine pesticides, and PAHs. The team will present the status of additional water quality monitoring, the modeling platform, and ongoing work to define TMDL endpoints. Additionally, EPA, MDE, and DOEE wish to inform attendees about the collaborative effort to develop revised TMDLs for trash in the Anacostia Watershed. EPA is currently seeking readily available data from the public that can be used to benefit the development of the trash TMDLs.
