<p><b>General Requirements</b></p>	<p>. . . continue to implement a public education campaign including but not limited to an education program aimed at residents, businesses, industries, elected officials, policy makers, planning staff and other employees of the permittee. The purpose is . . . to reduce or eliminate behaviors and practices that cause or contribute to adverse stormwater impacts. Education initiatives may be developed locally or regionally. . . . The outreach program shall be designed to achieve measurable improvements in the target audience's understanding of stormwater pollution and steps they can take to reduce their impacts. Audiences and subject areas to be considered include (a comprehensive list of audiences and messages is included). . . . shall continue to measure the understanding and adoption of selected targeted behaviors among the targeted audiences. The resulting measurements shall be used to direct education and outreach resources most effectively, as well as evaluated changes in adoption of targeted behaviors.</p>	<p>. . . continue to implement a public education and outreach campaign to reduce stormwater pollutants. - . . . continue to include ongoing opportunities for public involvement through advisory councils, watershed associations and/or committees, participation in developing updates to the stormwater fee system, stewardship programs, environmental activities or other similar activities. . . facilitate opportunities for direct action, educational, and volunteer programs such as riparian planting, volunteer monitoring programs, storm drain marking, or stream cleanup programs.
  - . . . finalize a Stormwater Management Guidebook to be available for wide-spread use by land use planners and developers. The Stormwater Management Guidebook shall provide regular updates . . . (on) stormwater management technologies. . .
  - . . . provide key industry, regulatory, and other stakeholders, with information regarding . . . green infrastructure practices contained in the Stormwater Management Guidebook through a training program.
  - . . . shall continue to implement an on-going training program for those employees specified below, and any other employees whose job functions may impact stormwater program implementation.
- Provide information to the general public about the benefits of:

    - the importance of community stormwater management facility maintenance;
    - proper erosion and sediment control practices
    - car care
    - Improving private well and septic system management
  - Establish and publicize a compliance hotline or similar mechanism for public reporting of water quality complaints, including suspected illicit discharges, illegal dumping, and spills.
  - Provide information regarding the following water quality issues to the regulated community when requested:
    - NPDES permitting requirements
    - Pollution prevention plan development
    - Proper housekeeping
    - Spill prevention and response.

    - Residential and community stormwater management implementation and facility maintenance
